What you need to know

This fact sheet provides key updates on practice staffing, testing and treatment, and information to keep your practice viable during the COVID-19 pandemic.

COVID-19 Vaccine Information

- 1. HCMS has created a <u>COVID-19 Vaccine FAQs for Physicians</u> to answer questions such as <u>where to get the vaccine</u> and information on how to register to administer the vaccine.
- 2. HCPH Vaccine Locations for Healthcare Workers
 - o HCPH has been administering a limited supply of COVID-19 vaccines to designated members of Tier 1A and 1B. Go to the <u>HCPH website</u> for regular updates on when additional vaccines will be available.
- 3. Houston Health Department
 - a. The Houston Health Department is offering vaccine to those who meet the Phase 1A and Phase 1B criteria. All appointments for the Houston Health Department vaccine clinic are filled for the remainder of January 2021. No additional appointments are being made. Check HHD">HHD website for updates.

Treatment and Testing

- 1. The FDA approved the antiviral drug Veklury (remdesivir) for use in adult and pediatric patients 12 years of age and older and weighing about 88 pounds for the treatment of COVID-19 requiring hospitalization. See the <u>FAQs on</u> Remdesivir.
- 2. FDA approved an emergency use authorization for the investigational monoclonal antibody therapy Bamlanivimab for the treatment of mild-to-moderate COVID-19 in adult and pediatric patients. Go to https://www.fda.gov/media/143603/download for more information.

Testing

- 1. The FDA has issued an emergency use authorization for the first COVID-19 diagnostic test for self-testing at home and that provides rapid results. The Lucira COVID-19 All-In-One Test Kit is a molecular (real-time loop mediated amplification reaction) single use test that is intended to detect the novel coronavirus SARS-CoV-2 that causes COVID-19. The test is available by prescription only. Click here for details.
